CMRC Now Accepting Nominations

To All CMRC Members

It is that time of year again when we accept nominations for the various club positions that are due for election. This year there are three positions to be elected, Vice President, Secretary, and Director – Scheduling.

The nominating committee this year is Ralph Watson, Ed Potts & Paul Falk (Chair). Please contact anyone on the committee to place yourself or other club member in nomination no later than the September 9, 2024 general meeting. At the end of the meeting the ballot will be established for the October 14, 2024 election. The nominations procedures are detailed in the club by-laws. The relevant sections are 5.2 &5.3 and are shown here for your convenience and can found in the members only area of the Club web site, Crossville trains.org. 5.2 Nominations

Nominations for the office of President, Vice President, Secretary, Treasurer and three At-Large Directors, as applicable, shall be accepted and verified by the Nominating Committee starting before the regular meeting in September and continuing through the start of the election meeting in October. Nominations from the floor shall be permitted in the September regular meeting.

5.3 Candidate Eligibility Candidates shall be Active Members or Life Members in good standing of the Club. Candidates shall be permitted to run for one office only. Descriptions of the three(3) positions for this election are detailed below.

The Vice President position is described in the by-laws section 3.3

3.3 Vice President

The Vice President shall act in the place of the President in the event of the latter's absence, or his or her inability or refusal to act. The Vice President shall immediately succeed to the office of the President in the event of resignation, death or disqualification of the President. The Vice President shall assist the President in the performance of the President's duties, and in conducting the Club's business. (11/03/03)

The Secretary position is described in the by-laws section 3.4

3.4 Secretary. The secretary shall conduct the correspondence pertaining to the business

of the Club and keep the official records of the Club. The Secretary shall also give notice of all regular, additional, and election meetings of the Club, and keep and publish, within 10 calendar days, minutes of all meetings of the Club and the Board of Directors, as well as performing such other duties as the President may from time to time request.

The At Large Directors position is described in the by-laws section 3.6

3.6 At Large Directors The At-Large Directors should consist of: Director of Scheduling and Attendance, Director of Suite Front End, and Director of Utility. A concise description of their duties is locate in Policies of Crossville Model Railroad Club.

Policies Attachment 12(1)

Director - Schedule/ Attendance

The member serving as Director – Schedule/Attendance is responsible for accomplishing the following tasks. Other members may assist when available or required.

- 1. Preparing a coordinated monthly schedule which combines the schedule submitted by the HO/N/Z group and the schedule submitted by the O/G group.
- 2. Post a copy of the coordinated schedule on the bulletin board located outside the suite office.
- 3. Forward a copy of the schedule to the Secretary to be forwarded to all Club members.
- 4. In the case where there is an inadequate number of members to staff the suite for a day, ask the secretary to send out an email to all members asking for additional help for that particular day.
- 5. Report unusual situations to the Board of Directors.
- 6. Provide a 'notebook' where members working an assigned shift in the suite will be able to 'sign in'.
- 7. Will periodically take the sign in sheets and record the information on an "Annual Cumulative Attendance Report".
- 8. Monthly, review the information on the Annual Cumulative Attendance Report and, applying the guidelines in the Club Policies, make appropriate contact with various members to determine the reason for any absences and report this information to the Board of Directors for further action, if any.
- 9. Such additional duties that may be assigned by the Board of Directors.










This is the layout Ralph and I bought in West Virgina in June. It is ready for reassembly but needs some wiring work and some minor scenery repair are needed.
